## INVITATION TO BID FOR GOODS 2016-067 PROCUREMENT OF CATERING SERVICES

The City Government of Catbalogan, through the CY 2016 City Health Office, HRMo GAD, PNP and CY 2015 BUB Fund intends to apply the amount of Four Hundred Thirty Five Thousand One Hundred Pesos (P435,100.00) Only, being the Approved Budget for the Contract (ABC) to payments under the contract for Goods 2016- 067. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The City Government of Catbalogan now invites bids for the Procurement of Catering Services. Delivery of the Goods is during activity period until Dec. 31, 2016 from the receipt of Notice to Proceed. Bidders should have completed, within five years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder

is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from City Government of Catbalogan City Engineering Office 4th Floor City Hall and inspect the Bidding Documents at the address given below during 2:00pm-5:00pm on regular working days.

A complete set of Bidding Documents may be acquired by interested Bidders on October 31, 2016 until November 7, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Hundred pesos (500.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

Bids must be delivered to the City Engineering Office 4th Floor City Hall Catbalogan City on or before 2:00pm of November 7, 2016. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1.

Bid opening shall be on 2:00pm of November 7, 2016 at City Engineering Office 4th Floor City Hall Catbalogan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of Catbalogan reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
