WHEREAS, the City Government of Catbalogan advertised the Invitation to Bid for the SUPPLY AND DELIVERY OF BUSINESS PLATES (GOODS 2017-039) for the City Government of CATBALOGAN and posted the same in the PhilGEPS, Catbalogan website and conspicuous place (BAC Bulletin Board) at the premises of the City Government continuously from October 25, 2017 until December 4, 2017-10:00am;

WHEREAS, in response to the said advertisements, four (4) bidders, namely: 5J'S METAL CRAFT AND GENERAL MERCHANDISE COMPANY LTD., JOSHUA MIGUEL TRADING, TRES NIÑAS GEN. MERCHANT AND PRINTING & DVK PHILIPPINES ENTERPRISES purchased the bid document for the SUPPLY AND DELIVERY OF BUSINESS PLATES (GOODS 2017-039), but only 5J'S METAL CRAFT AND GENERAL MERCHANDISE COMPANY LTD. & JOSHUA MIGUEL TRADING has passed the preliminary examination of bids;


