excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The City Government of Catbalogan now invites bids for Supply and Delivery of Meals and Snacks.1 Delivery of the Goods is required from receipt of Notice to Proceed until June 2019. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the

"Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Bids and Awards Committee Secretariat 2nd Floor, Sangguniang Panlungsod Office, City Hall, Catbalogan City and inspect the Bidding Documents at the address given below during Office hour 10:00am-5:00pm.

5. 7. Bids must be duly received by the BAC Secretariat at the address below on or before March 19, 2019 -2:00pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on March 19, 2019-2:00pm at Bids and Awards Committee Secretariat 2nd Floor, Sangguniang Panlungsod Office, City Hall, Catbalogan City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of Catbalogan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
