BAC Resolution Declaring ALVEZ COMMERCIAL INC. as the Bidder with the Single Calculated and Responsive Bid (SCRB) and Recommending Approval to Award by the Honorable City Mayor

WHEREAS, the City Government of Catbalogan advertised the Invitation to Bid for the SUPPLY AND DELIVERY OF ONE (1) LOT EMPTY SACKS @ 10 KILOS/PC AND THREAD (BUNDLES) (REPUBLISHED) (GOODS 2019-004) for the City Government of CATBALOGAN and posted the same with the PhilGEPS and Catbalogan City websites and on the BAC Bulletin Board of the City Government, continuously from May 04, 2019 until May 28, 2019-2:00pm;

WHEREAS, in response to the said advertisements, only one (1) bidder purchased the bid document for the SUPPLY AND DELIVERY OF ONE (1) LOT EMPTY SACKS @ 10 KILOS/PC AND THREAD (BUNDLE) (REPUBLISHED) (GOODS 2019-004) and dropped the bid proposals on or before May 28, 2019-2:00pm. The bid opening was conducted on May 28, 2019-2:00pm, and ALVEZ COMMERCIAL INC. passed the preliminary examination of bids;

WHEREAS, the bid proposal of the bidder was found to be substantially complying:


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


