BAC Resolution Declaring TCO SECURITY AGENCY as the Bidder with the Single Calculated and Responsive Bid and Recommending Approval to Award by the Honorable City Mayor

WHEREAS, the City Government of Catbalogan advertised the Invitation to Bid for the PROCUREMENT OF SECURITY SERVICES (GOODS 2019-020) for the City Government of CATBALOGAN and posted the same with the PhilGEPS and Catbalogan City websites and on the BAC Bulletin Board of the City Government, continuously from August 6, 2019 until August 27, 2019-2:00pm;

WHEREAS, in response to the said advertisements, only one (1) bidder, namely: TCO SECURITY AGENCY purchased the bid document for the PROCUREMENT OF SECURITY SERVICES (GOODS 2019-020) and dropped the bid proposals on or before August 27, 2019-2:00pm. The bid opening was conducted on August 27, 2019-2:00pm, and TCO SECURITY AGENCY passed the preliminary examination of bids;
