- The City Government of Catbalogan, through the CY 2019 NON OFFICE intends to apply the sum of Three Million Pesos (P3,000,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for Infra 2019-020. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The City Government of Catbalogan, now invites bids for Rehabilitation of Electrical System, Catbalogan City Hall, Catbalogan City Completion of the Works is required 45 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from BIDS AND AWARD COMMITTEE 2ND FLOOR City Hall Catbalogan City, Procuring Entity] and inspect the Bidding Documents at the address given below from 10:00am-5:00pm.

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The City Government of Catbalogan will hold a Pre-Bid Conference on September 27, 2019 -10:00am at the Bids and Awards Committee Office, 2nd Floor City Hall Catbalogan City,, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before October 9, 2019 – 2:00pm. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- Bid opening shall be on October 9, 2019 – 2:00pm at Bids and Awards Committee Office Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
