**WHEREAS**, in response to the said advertisements, only one (1) bidder, namely: ARAZA ENTERPRISES purchased the bid document for the GOODS 2019-017 SUPPLY AND DELIVERY OF VARIOUS SPARE PARTS (LOT 1 - SUPPLY AND DELIVERY OF VARIOUS SPARE PARTS & LOT 2 - SUPPLY AND DELIVERY OF VARIOUS SPARE PARTS (TIRES) and dropped the bid proposals at 10:30am on August 13, 2019-2:00pm. The bid opening was conducted on August 13, 2019-2:00pm, and ARAZA ENTERPRISES passed the preliminary examination of bids;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


