**Contract Agreement**

THIS AGREEMENT, made this 2ND day of SEPT., **2019** between the City Government of Catbalogan represented by **HON. DEXTER M. UY**, City Mayor (hereinafter called "the Entity") of the one part and **ARAZA ENTERPRISES** represented by **MR. FRANCISCO B. ARAZA** (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services of **GOODS 2019-017 SUPPLY AND DELIVERY OF VARIOUS SPARE PARTS** for:

**LOT 1- SUPPLY & DELIVERY OF VARIOUS SPARE PARTS - P723,308.00**

**LOT 2 - SUPPLY & DELIVERY OF SPARE PARTS (TIRES) – P379,550.00**

and has accepted a Bid by the Supplier for the Supply of those goods and services in the total amount of **ONE MILLION ONE HUNDRED TWO THOUSAND EIGHT HUNDRED FIFTY EIGHT PESOS ONLY (P1,102,858.00)** (herein called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
  - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract; and
  - (f) the Entity's Notification of Award
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.


