- The City Government of Catbalogan, through the CY 2019 20% CDF intends to apply the sum of One Million Five Hundred Thousand Pesos (P1,500,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for Infra 2019-025. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The City Government of Catbalogan, now invites bids for Construction of Drainage Canal and Pathway (130.00 meters) to include Removal of Existing Structures, Excavation, Gravel Bedding, Formworks, Concrete Works, Steel Works, Restoration of Damaged Structures, Declogging of Drainage Canal Billboards, Barricades & Warning Signs Completion of the Works is required 45 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. The City Government of Catbalogan will hold a Pre-Bid Conference on December 6, 2019 -10:00am at the Bids and Awards Committee Office, 2nd Floor City Hall Catbalogan City,, which shall be open to prospective bidders.

8. Bids must be duly received by the BAC Secretariat at the address below on or before December 18, 2019 – 2:00pm. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 18, 2019 – 2:00pm at Bids and Awards Committee Office Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of Catbalogan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
