**WHEREAS**, the City Government of Catbalogan advertised Invitations to Bid for the project **INFRA 2020-004 CONSTRUCTION OF SIDEWALK AND DRAINAGE CANAL, P4 BRGY. CANLAPWAS, CATBALOGAN CITY with an Approved Budget for the Contract (ABC) of P8,000,000.00** which were posted in the PhilGEPS and LGU Catbalogan City websites and on the BAC Bulletin Board of the Catbalogan City Hall continuously from January 4, 2020 until Bid Opening on January 27, 2020-2:00pm.

**WHEREAS**, in response to the said advertisement, two (2) construction firms purchased the bid documents for the said project, namely: JC BUILDERS AND CONSTRUCTION SUPPLY and VHITS D.G. BUILDERS AND ENTERPRISES.

**WHEREAS**, two (2) bids were received by the BAC on January 27, 2020-2:00pm and both construction firm passed the preliminary examination of bids;


