RESOLUTION DECLARING JFR CONSTRUCTION AS THE BIDDER WITH THE LOWEST, CALCULATED AND RESPONSIVE BID and RECOMMENDING TO AWARD BY THE HONORABLE CITY MAYOR

WHEREAS, the Bids and Awards Committee (BAC) intended to procure for the infrastructure **INFRA 2019-004 REPAIR/REHAB OF BFP OFFICE, BFP FIRE STATION, Catbalogan City** with an Approved Budget for the Contract (ABC) **Two Hundred Thousand Pesos (P200, 000.00)** for City Engineering Office.

WHEREAS, the BAC recommended to the honorable City Mayor **Small Value** as the mode of procurement for the above-stated bidding considering the said infra do not fall under shopping and whose ABC does not exceed the P400, 000.00 threshold for a fifth class city like Catbalogan pursuant to Section 53.9 Rule VIII of the implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act.

WHEREAS, the BAC invited and engaged in negotiations Three (3) Proprietor with good track records and in good standing with the City Government, bidders for Infra 2019-004 NP namely: 1) Bench Construction & Supply 2) JFR Construction and 3) Maga Construction and Supplies.

WHEREAS, said bidders submitted their respective quotations and upon careful and judicious evaluation by the BAC, **JFR CONSTRUCTION** was assessed to have tendered the best and final offer of **ONE HUNDRED NINETY SIX THOUSAND THREE HUNDRED SEVENTY EIGHT PESOS AND 58/100 (P196, 378.58) ONLY** vis-a'-vis the Approved Budget for the Contract of **Two Hundred Thousand Pesos Only (P200, 000.00)**, meeting the minimum technical requirements, conditions and specifications.

NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby RESOLVE, as it is hereby RESOLVED:

- A) To declare JFR CONSTRUCTION, as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for the infra 2019-004(NP) Repair/Rehab of BFP Office, BFP Fire Station, Catbalogan City, and

B) To recommend the award of contract to JFR CONSTRUCTION, for the Procurement of Infra 2019-004(NP) Repair/Rehab of BFP Office, BFP Fire Station, Catbalogan City to the Honorable City Mayor or her duly authorized representative.
