THIS AGREEMENT, made this FEB 12 2020 day of 2020 between the City Government of Catbalogan represented by **HON. DEXTER M. UY**, City Mayor (hereinafter called the "Entity") and **JFR CONSTRUCTION** of # 17 Bliss Brgy. Canlapwas, Catbalogan City, represented by **MR. JOJO F. REMIGIO**, Proprietor (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **INFRA 2020-002 REPAIR/REHABILITATION OF CANAL, BRGY. GUINDAPUNAN,, CATBALOGAN CITY** with project description of Furnishing of Materials, Labor & Equipment for the repair/rehab of canal 149.00 meters and to include all items stated and the Entity has accepted the Bid for **ONE MILLION NINE HUNDRED NINETY SIX THOUSAND NINE HUNDRED ELEVEN PESOS AND 24/100 (P1,996,911.24)** by the Contractor for the execution and completion of such works during the period of **Forty Seven (47) calendar days** and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Construction Schedule and S-Curve
  - (n) Construction Method
  - (o) Equipment Utilization
  - (p) Manpower Schedule
  - (q) PERT/CPM
  - (r) Other contract documents that may be required by existing laws and/or the Entity


- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


