INVITATION TO BID FOR GOODS 2020-006 SUPPLY AND DELIVERY OF CATERING SERVICES MEALS AND SNACKS

1. The City Government of Catbalogan, through the CY 2020 FUND of Different Offices and Programs intends to apply the sum of Six Million Seven Hundred Ninety-Seven Thousand Seven Hundred Pesos (P6,797,700.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for Goods 2020-006. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Catbalogan now invites bids for Supply and Delivery of Catering Services Meals and Snacks. Delivery of the Goods is required from the Notice to Proceed until December 31, 2020. Bidders should have completed, within [insert relevant period] from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent

(60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from BIDS AND AWARDS COMMITTEE SECRETARIAT and inspect the Bidding Documents at the address given below from 10:00 AM TO 5:00 PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on February 10 to March 2, 2020 – 2:00 pm from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P10,000.00) only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The City Government of Catbalogan will hold a Pre-Bid Conference on February 18, 2020 – 10:00 am at Bids and Awards Committee 2nd Floor City Hall Catbalogan City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before March 2, 2020 – 2:00 pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on March 2, 2020 – 2:00 pm at Bids and Awards Committee 2nd Floor City Hall Catbalogan City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Bidders of Catering Services shall be easily accessed by the end-user and their services are readily available when needed.

9. The City Government of Catbalogan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
