RESOLUTION ENDORSING THE RECOMMENDATION OF CITY HEALTH OFFICE TO AWARD BAJ PHARMACEUTICALS AS THE SUPPLIER TO PROVIDE VARIOUS MEDICINES TO ADDRESS COVID-19 PANDEMIC UNDER NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES MODALITY AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR

WHEREAS, in response to the current COVID-19 situation prevailing in the city, the City Government of Catbalogan, through the City Health Office, identified various medicines to be immediately purchased to address the possible incursion of COVID-19 into the City.

WHEREAS, the City Health Office quantified the various medicines needed to address the COVID-19 pandemic and subsequently prepared the Purchase Request (PR) with corresponding costings under PR No. 2020-05-0062 (Amlodipine besilate 5mg ta 100's etc...) May 14, 2020 in the total amount of Four Million Nine Hundred Ninety Nine Thousand Six Hundred Pesos (P4,999,600.00) which was duly approved by the Honorable Mayor as evidenced by Annex "A".

WHEREAS, GPPB Resolution No. 03-2020 dated March 9, 2020 authorizes the Head of Procuring Entity, to delegate an End-User unit to directly negotiate with a legally, technically and financially capable service provider that would satisfy the requirements needed for such services.

WHEREAS, the Honorable City Mayor delegated the City Health Office to directly negotiate with a company or firm that would adequately address said needs, attached herewith as Annex "B".

WHEREAS, the City Health Office conducted a survey on May 15, 2020 companies or firms with good track records and in good standing with the City Government that could adequately provide the said items, and came up with the findings that BAJ PHARMACEUTICALS meets the required requirements.


WHEREAS, CSWDO directly negotiated with BAJ PHARMACEUTICALS and sent them a Request for Quotation (RFQ) Annex "C" for various medicines dated May 15, 2020 and the latter responded with an offer of Four Million Nine Hundred Ninety Nine Thousand Six Hundred Pesos (P4,999,600.00) which is lower than the estimated amount reflected on the purchase request.

WHEREAS, the City Health Office are amenable to the rate quoted above and considers it reasonable taking into consideration all factors, including urgent and appropriate response and measures on a daily manner in addressing the COVID – 19 threat, as cited in Request for Quotation (RFQ)

WHEREFORE, RESOLVED, as it is hereby resolved, to endorse the recommendation of City Health Office to award BAJ Pharmaceuticals the Supply and Delivery of Various Medicines under negotiated procurement through Emergency cases to address the pandemic COVID-19 in the amount of Four Million Nine Hundred Ninety Nine Thousand Three Hundred Pesos (P4,999,300.00).


