**BAC Resolution Declaring BAJ PHARMACEUTICALS as the Bidder with the Single Calculated and Responsive Bid and Recommending Approval to Award by the Honorable City Mayor**

**RESOLUTION NO. 2020-099-04**

**WHEREAS**, the City Government of Catbalogan advertised an Invitation to Bid for the SUPPLY AND DELIVERY OF ONE (1) LOT VARIOUS MEDICINES (GOODS 2020-016) for the City Government of CATBALOGAN and posted the same with the PhilGEPS and Catbalogan City websites and on the BAC Bulletin Board of the City Government, continuously from July 15, 2020, until August 5, 2020-2:00pm;

**WHEREAS**, in response to the said advertisements, two (2) prospective bidders, namely: BAJ PHARMACEUTICALS and LR ENTERPRISES purchased bid documents for the above-stated project and subsequently dropped their respective bids before the scheduled deadline;

**WHEREAS**, the BAC first opened the technical component of LR ENTERPRISES and was rated as "Failed" upon preliminary examination of its technical component and thus was evaluated as Non-Complying.

**WHEREAS**, the bid documents of BAJ Pharmaceuticals was found to be substantially complying in their technical as well as in the financial component, with a bid lower than the ABC:
