**RESOLUTION ENDORSING THE RECOMMENDATION OF CITY MAYORS OFFICE' AUTHORIZED REPRESENTATIVE TO AWARD JUVIES RESORT HOTEL & RESTAURANT FOR THE HOTEL ACCOMMODATION AS A SPECIAL CARE FACILITY FOR THE ISOLATION OF SUSPECTED COVID 19 CASES UNDER NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES MODALITY.**

**WHEREAS**, in response to the current COVID-19 situation prevailing in the city, the City Government of Catbalogan, through the City Mayors Office, needs to provide hotel accommodation as special care facility for the Isolation of suspected COVID-19 individuals in the city.

**WHEREAS**, the City Mayor's Office identified the components and features of a special care facility of a hotel, and the corresponding unit costings for the above-mentioned hotel accommodation and subsequently prepared the Purchase Request under PR no. 2020-04-0042-1 dated April 27, 2020 in the amount of One Million Eight Hundred Thousand Pesos (P1,800,000.00) for the inclusive date May 1 -July 31, 2020, which was duly approved by the Honorable City Mayor as evidenced by Annex "A".

**WHEREAS**, GPPB Resolution No. 03-2020 dated March 9, 2020 authorizes the Head of Procuring Entity, to delegate the End-User unit to directly negotiate with a legally, technically and financially capable service provider that would satisfy the requirements needed for such services.

**WHEREAS**, the Honorable City Mayor delegated a Representative from the Mayors Office to directly negotiate with a hotel establishment within the City that would adequately address said needs, attached herewith as Annex "B".

**WHEREAS**, the City Mayors Office' authorized representative conducted a survey on April 27, 2020 on hotel establishments that could adequately provide a special care facility for the isolation of suspected COVID-19 cases and came up with the findings that Juvies Resort Hotel & Restaurant meets the hotel accommodation requirement as identified by the City Mayors Office' authorized representative.

**WHEREAS**, the City Mayors Office' authorized representative directly negotiated with Juvies Resort Hotel & Restaurant and sent them a Request for Quotation (RFQ) Annex "C" dated April 27, 2020 and the latter responded with an offer of One Million Eight Hundred Thousand Pesos (P1,800,000.00), for inclusive date May 1-July 31, 2020.

**WHEREAS**, the City Mayors Office' authorized representative is amenable to the rate quoted above and considers it reasonable taking into consideration all factors, including urgent and appropriate response and measures on a daily manner in addressing the COVID – 19 threat, as cited in the aforementioned Request for Quotation (RFQ).






