Resolution No. 2020-087 (AWARD)

**RESOLUTION DECLARING CATBALOGAN MARC PRINTING PRESS AS THE BIDDER WITH THE SINGLE, CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR**

WHEREAS, the Bids and Awards Committee (BAC) intended to procure **1,500 pcs. Real Property Tax Account Register (RPTAR)** with an Approved Budget for the Contract (ABC) of **SIXTY SEVEN THOUSAND FIVE HUNDRED PESOS (P67,500.00)** for City Treasurer's Office activities.

WHEREAS, the BAC recommended to the honorable City Mayor **Small Value** as the mode of procurement for the above-stated bidding considering that said service does not fall under shopping and whose ABC does not exceed the P400,000.00 threshold for a fifth class city like Catbalogan pursuant to Rule XVI Section 53.9 of the Implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act.

WHEREAS the BAC invited suppliers registered with the Philgeps and included in the registry record of LGU Catbalogan City namely: 1) CATBALOGAN MARC PRINTING PRESS 2) A. SALES STORE Catbalogan City and 3) BBCS Data System Catbalogan City but only Catbalogan Marc Printing Press responded the invitation for the Supply and Delivery of 1,500 pcs Real Property Tax Account Register (RPTAR)


WHEREAS, said bidder submitted his quotation and upon careful and judicious evaluation by the BAC, **CATBALOGAN MARC PRINTING PRESS** was assessed to have tendered the best and final offer of **SIXTY SEVEN THOUSAND FIVE HUNDRED PESOS (P67,500.00)** vis-à-vis the Approved Budget for the Contract of **Sixty Seven Thousand Five Hundred Pesos (P67,500.00)** meeting the minimum technical requirements, conditions, and specifications.

NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby RESOLVE, as it is hereby RESOLVED:




