RESOLUTION ENDORSING THE RECOMMENDATION OF CITY MAYORS OFFICE' AUTHORIZED REPRESENTATIVE TO AWARD M GRAND ROYALE AS THE PROVIDER FOR MEALS AND SNACKS UNDER NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES MODALITY FOR THE FRONTLINERS, VOLUNTEERS, SUSPECTED COVID 19-INDIVIDUALS AND FOR VARIOUS COVID 19 RELATED MATTERS AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR

WHEREAS, in response to the current COVID-19 situation prevailing in the city, the City Government of Catbalogan, through the City Mayors Office , needs to provide food to the frontliners, volunteers, suspected COVID 19 individuals and for meetings in connection with COVID 19- related matters.

WHEREAS, the City Mayors Office quantified the items of work, catering schedule and the corresponding unit costings for the above-mentioned catering services and subsequently prepared the Purchase Request under PR no. 2020-03-0010 dated March 11, 2020 in the amount of Two Million Four Hundred Forty Thousand Pesos (P2,440,000.00), which was duly approved by the Honorable Mayor as evidenced by Annex" A".

WHEREAS, GPPB Resolution No. 03-2020 dated March 9, 2020 authorizes the Head of Procuring Entity, to delegate the End-User unit to directly negotiate with a legally, technically and financially capable service provider that would satisfy the requirements needed for such services.

WHEREAS, the Honorable City Mayor delegated the City Mayors Office representative to directly negotiate with caterers within the City that would adequately address said needs, attached herewith as Annex "B".

WHEREAS, the City Mayors Office conducted a survey on March 11, 2020 on caterers that could adequately provide food services to frontliners, volunteers, suspected COVID 19 and for different committee meetings as required, and came up with the findings that M Grand Royale meets the catering services required requirements.


WHEREAS, City Mayors Office' authorized representative directly negotiated with M GRAND ROYALE and sent them a Request for Quotation (RFQ) "Annex C" for catering services dated March 11, 2020 and the latter responded with an offer of Two Million Four Hundred Forty Thousand Pesos (P2,440,00000).


WHEREAS, the City Mayors Office' authorized representative is amenable to the rate quoted above and considers it reasonable taking into consideration all factors, including urgent and appropriate response and measures on a daily manner in addressing the COVID – 19 threat, as cited in the Request for Quotation (RFQ).

WHEREFORE, RESOLVED, as it is hereby resolve, to endorse the recommendation of City Mayors Office' authorized representative to award M. GRAND ROYAL the CATERING SERVICES for meals and snacks under Negotiated Procurement through Emergency cases for frontliners, volunteers, suspected COVID 19 individuals and for committee meetings in connection with the COVID 19 emergency cases in the amount of Two Million Four Hundred Forty Thousand Pesos (P2,440,000.00).






