RESOLUTION ENDORSING THE RECOMMENDATION OF CSWDO TO AWARD LESTER LACE ENTERPRISES AS THE PROVIDER FOR VARIOUS GROCERIES UNDER NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES MODALITY IN SUPPORT OF THE BASIC NEEDS OF CATBALOGANONS AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR

WHEREAS, in response to the current COVID-19 situation prevailing in the city, the City Government of Catbalogan, through the City Social Welfare Development Office (CSWDO), needs to provide groceries to support the basic needs of Catbaloganons in connection with the COVID-19 pandemic.

WHEREAS, the CSWDO quantified the grocery items and the corresponding unit costings for the above-mentioned various groceries and subsequently prepared the Purchase Request (PR) with PR No. 2020-04-0062-1 dated May 14, 2020 in the total amount of Seventy Three Thousand Eight Hundred Sixteen Pesos (P73,816.00), which was duly approved by the Honorable Mayor as evidenced by Annex "A".

WHEREAS, GPPB Resolution No. 03-2020 dated March 9, 2020 authorizes the Head of Procuring Entity, to delegate an End-User unit to directly negotiate with a legally, technically and financially capable service provider that would satisfy the requirements needed for such services.

WHEREAS, the Honorable City Mayor delegated the City Social Welfare Development Office to directly negotiate with grocery establishments within the city that would adequately address said needs, attached herewith as Annex "B".

WHEREAS, the CSWDO conducted a survey on May 15, 2020 on different establishments within Catbalogan that could adequately provide the various groceries, and came up with the findings that LESTER LACE ENTERPRISES meets the various groceries and the required requirements.


WHEREAS, CSWDO directly negotiated with LESTER LACE ENTERPRISES and sent them a Request for Quotation (RFQ) Annex "C" for various groceries dated May 15, 2020 and the latter responded with an offer of Seventy Three Thousand Eight Hundred Sixteen Pesos (P73,816.00).

WHEREAS, the CSWDO are amenable to the rate quoted above and considers it reasonable taking into consideration all factors, including urgent and appropriate response and measures on a daily manner in addressing the COVID – 19 threat, as cited in Request for Quotation (RFQ).


WHEREFORE, RESOLVED, as it is hereby resolved, to endorse the recommendation of CSWDO to award LESTER LACE ENTERPRISES as the supplier of needed Various groceries under Negotiated Procurement through Emergency Cases in support of the basic needs of Catbaloganons as response to the COVID-19 pandemic in the amount of Seventy Three Thousand Eight Hundred Sixteen Pesos (P73,816.00).


