**RESOLUTION ENDORSING THE RECOMMENDATION OF CCDRRMO TO AWARD MHIRADGE ENTERPRISES AS THE PROVIDER FOR UNIFORMS UNDER NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES MODALITY AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR**

**WHEREAS**, in response to the COVID-19 situation prevailing in the city, the City Government of Catbalogan, through the City Health Office (CHO), needs to provide uniforms to City Health personnel assigned as Health Emergency Management System (HEMS) in response during emergency cases and COVID-19 pandemic.

**WHEREAS**, the City Health Office, quantified the number of uniforms and the corresponding unit costings for the above mentioned uniforms and subsequently prepared the Purchase Request (PR) with PR No. 2020-04-0060 dated April 28, 2020 in the total amount of Seventy Thousand Nine Hundred Fifty Pesos (P70,950.00), which was duly approved by the honorable City Mayor as evidenced by Annex "A".

**WHEREAS**, GPPB Resolution No. 03-2020 dated March 9, 2020, authorizes the Head of Procuring Entity, to delegate an End-user unit to directly negotiate with a legally, technically and financially capable service provider that would satisfy the requirements needed for such services.

**WHEREAS**, the Honorable City Mayor delegated the City Health Office to directly negotiate with the supplier within the city that would adequately address said needs, attached herewith as Annex "B".

**WHEREAS**, the City Health Office conducted a survey on April 30, 2020 of different supplier on uniforms within Catbalogan City that could adequately provide the said uniforms, and came up with the findings that MHIRADGE ENTERPRISES meet the required requirements.


**WHEREAS**, City Health Office directly negotiated with **MHIRADGE ENTERPRISES** and sent them a Request for Quotation (RFQ) Annex "C" for Uniforms dated April 30, 2020 and the latter responded with an offer of Seventy Thousand Ninety Pesos (P70,090.00) which is lower than the estimated price cited in the Purchase Request.

**WHEREAS**, the City Health Office is amenable to the rate quoted above and considers it reasonable taking into consideration all factors, including urgent and appropriate response and measures on a daily manner in addressing the COVID – 19 threat, as cited in Request for Quotation (RFQ).


**WHEREFORE, RESOLVED**, as it is hereby resolved, to endorse the recommendation of City Health Office to award MHIRADGE ENTERPRISES as the supplier of UNIFORMS under negotiated procurement through Emergency Case modality to be used by the Health Emergency Management System (HEMS) in response to the COVID-19 pandemic in the amount of Seventy Nine Thousand Nine Hundred Pesos (P70,090.00).


