**RESOLUTION RECOMMENDING TO THE HONORABLE DEXTER M. UY TO ADOPT NEGOTIATED PROCUREMENT UNDER EMERGENCY CASE MODALITY AS THE MODE OF PROCUREMENT FOR THE PURCHASE OF VARIOUS GROCERY ITEMS AND TOILETRIES**

**WHEREAS**, Pursuant to Section 7.3.2 of the Implementing Rules and Regulations (IRR) of the Government Procurement Reform Act (R.A. 9184), the City Mayor's Office, Catbalogan City prepared its Supplemental Project Procurement Management Plan (SPPMP) for Calendar Year 2020 attached as "ANNEX A" ;

**WHEREAS**, said SPPMP and Purchase Request call for the procurement of various grocery items and toiletries to be used by the frontliners and maintenance of isolation facilities (COVID 19) as per Purchase Requests No. 2020-07-0015 and 2020-07-0016 both dated July 07, 2020 in the total amount of One Hundred Eighty Eight Thousand Two Hundred Seventy Three Pesos (P188,273.00);

**WHEREAS**, in accordance with Section 10 of the Implementing Rules and Regulations (IRR) of the Government Procurement Reform Act (R.A. 9184), as a general rule, the Bids and Awards Committee (BAC) adopts public bidding as the general mode of procurement and that the procurement program allows sufficient lead time for such public bidding;



**WHEREFORE, RESOLVED**, as it hereby resolved to recommend to the City Mayor to adopt Negotiated Procurement through Emergency Case as the mode of procurement for the purchase of various grocery items and toiletries under Purchase Requests No. 2020-07-0015 and 2020-07-0016, with an Approved Budget for the Contract of One Hundred Eighty Eight Thousand Two Hundred Seventy Three Pesos (P188,273.00) only.

**RESOLUTION RECOMMENDING TO THE HONORABLE CITY MAYOR TO AWARD THE PROCUREMENT THROUGH EMERGENCY CASE MODALITY TO SUPPLIER SWEETSELL MINI MART FOR THE PURCHASE OF VARIOUS GROCERY ITEMS AND TOILETRIES.**

WHEREAS, the City Government of Catbalogan intends to immediately address the needs of the frontliners and maintenance of isolation facilities in response to the prevailing COVID 19 outbreak within the City.

WHEREAS, the City Mayor's Office identify and quantify the necessary grocery items and toiletries in the total amount of One Hundred Eighty Eight Thousand Two Hundred Seventy Three Pesos (P188,273.00)

WHEREAS, the Bids and Awards Committee (BAC) recommended to the honorable City Mayor that the procurement for the above-stated items be conducted by negotiated procurement through emergency purchase pursuant to Rule XVI Sec. 53.2 of the Implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act.

WHEREAS, the rules provide that in cases of procurement in emergencies, the BAC can directly negotiate with a qualified supplier wherein one such requirement is a valid philgeps registration



NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby RESOLVE, as it is hereby RESOLVED:


