**RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY
TO ADOPT AGENCY-TO-AGENCY AS THE MODE OF PROCUREMENT**

WHEREAS, in accordance with Section 10 of IRR-A of Republic Act No. 9184, as a general rule wherein, the procuring entity concerned shall adopt public bidding as the general mode of procurement and shall see to it that the procurement program allows sufficient lead time for such public bidding;

WHEREAS, Rule XVI Section 53.5 of said IRR-A of RA 9184 allows the Procuring entity to directly negotiate on an Agency-to-Agency basis, provided that the same shall be resorted to only in highly exceptional cases, and whenever justified by the conditions as provided for in the said RA 9184 as such, the procuring entity intends to purchase Accountable Forms (Birth, Death and Foundling) from Philippine Statistic Office-Catbalogan City


WHEREAS, considering the relevant factors and attendant circumstances and after thorough and judicious evaluation on the specification as reflected in Purchase Request No. 2020-09-0014 Accountable Forms (Birth, Death and Foundling) of City Civil Registrar Office, Catbalogan dated September 22, 2020 the Committee finds that there is justifiable cause to consider the said purchase request as an exception to Sec. 10 of the aforesaid IRR-A of RA 9184.

RECOMMENDATION


IN VIEW THEREOF and in pursuant to Rule XVI of IRR-A of R.A. 9184, it is recommended that the following mode of procurement be adopted:

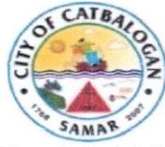

RESOLUTION DECLARING PSA-CATBALOGAN CITY AS THE AUTHORIZED GOVERNMENT AGENCY FOR NEGOTIATED PROCUREMENT THROUGH AGENCY TO AGENCY MODALITY FOR THE PURCHASE OF ACCOUNTABLE FORMS AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR

WHEREAS, the Bids and Awards Committee (BAC) intends to procure Accountable Forms (Birth, Death and Foundling) with an Approved Budget for the Contract (ABC) of **Twenty Seven Thousand Nine Hundred Sixty Five Pesos (P27,965.00)** for the City Civil Registrar Office Catbalogan City.

WHEREAS, the BAC recommended to the honorable City Mayor an **AGENCY TO AGENCY** as the mode of procurement for the above-stated procurement considering that said goods are government procurement pursuant to Rule XVI Sec. 53.5 of the Implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act, Which was subsequently approved by the latter.


