**RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY
TO ADOPT SECTION 53.6 (SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE
TECHNOLOGY AND MEDIA SERVICES) AS THE MODE OF PROCUREMENT**

WHEREAS, in accordance with Section 10 of IRR-A of Republic Act No. 9184, as a general rule wherein, the procuring entity concerned shall adopt public bidding as the general mode of procurement and shall see to it that the procurement program allows sufficient lead time for such public bidding;

WHEREAS, Rule XVI Section 53.6 of said IRR-A of RA 9184 allows the Procuring entity to directly negotiate on a Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services basis, provided that the same shall be resorted to only in highly exceptional cases, and whenever justified by the conditions as provided for in the said RA 9184 as such, the procuring entity intends to deliver IEC Campaign for COVID-19.

WHEREAS, considering the relevant factors and attendant circumstances and after thorough and judicious evaluation on the specification as reflected in Purchase Request No. 2020-09-0033 Catbalogan dated September 14, 2020 the Committee finds that there is justifiable cause to consider the said purchase request as an exception to Sec. 10 of the aforesaid IRR-A of RA 9184.


IN VIEW THEREOF and in pursuant to Rule XVI of IRR-A of R.A. 9184, it is recommended that the following mode of procurement be adopted:

RESOLUTION DECLARING HIRAYA THEATER PRODUCTION AND EVENTS MARKETING, AS THE PROVIDER OF IEC CAMPAIGN FOR COVID-19 UNDER NEGOTIATED PROCUREMENT THROUGH SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES MODALITY AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR

WHEREAS, the Bids and Awards Committee (BAC) intends to procure services on IEC Campaign for COVID-19 with an Approved Budget for the Contract (ABC) of **Two Hundred Thousand Pesos (P200,000.00) only** for the City Mayors Office Catbalogan City.

WHEREAS, the BAC recommended to the honorable City Mayor a Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services Modality as the mode of procurement for the above-stated procurement considering that said services are highly exceptional cases pursuant to Rule XVI Sec. 53.6 of the Implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act, Which was subsequently approved by the latter.


WHEREAS, the BAC negotiated with the Hiraya Theater Production and Events Marketing Modality and sent one (1) Request for Quotation (RFQ) and responded in the amount of Two Hundred Thousand Pesos (P200,000.00)

NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby RESOLVE, as it is hereby RESOLVED:
