**WHEREAS**, the City Government of Catbalogan advertised an Invitation to Bid for the ESTABLISHMENT AND INSTITUTIONALIZATION OF THE CITY'S E-MAGAZINE (REPUBLISHED) (GOODS 2021-006) for the City Government of CATBALOGAN and posted the same with the PhilGEPS and Catbalogan City websites and on the BAC Bulletin Board of the City Government, continuously from February 9, 2021 until March 1, 2021-2:00pm;

**WHEREAS**, in response to the said advertisements, only bidder, namely: BBCS DATA SYSTEMS purchased the bid for the ESTABLISHMENT AND INSTITUTIONALIZATION OF THE CITY'S E-MAGAZINE (REPUBLISHED) (GOODS 2021-006) and dropped their bid proposal at 10:20am on March 1, 2021. The bid opening was conducted on March 1, 2021-2:00pm, and BBCS DATA SYSTEMS was evaluated to have passed the preliminary examination of bids;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


