RESOLUTION DECLARING ASIA NOVO BOUTIQUE HOTEL INC. AS THE PROVIDER OF HOTEL ACCOMMODATION FOR FRONTLINERS UNDER NEGOTIATED EMERGENCY CASE MODALITY FOR THE CONTINUED RESPONSE OF COVID-19 PANDEMIC AND RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR.

WHEREAS, the City Inter-Agency Task Force on COVID-19 certified that Hotel Accommodation is part of the City's intervention to combat the COVID-19 pandemic situation (Annex "A).

WHEREAS, the City Mayor's Office did a detailed breakdown the numbers of hotels and the occupancy per room with an Approved Budget for the Contract (ABC) of One Million Three Hundred Seventy Three Thousand Pesos (P1,373,000.00) (Annex "B").

WHEREAS, the Bids and Awards Committee (BAC) intends to procure lease of Hotel accommodation for personnel directly involved in the COVID-19 pandemic through Negotiated Procurement Emergency Cases.

WHEREAS, the BAC recommended to the honorable City Mayor emergency case as the mode of procurement for the above-stated catering services considering that said goods fall under Negotiated Procurement Emergency Cases pursuant to Section 53.2 Rule XVI of the Implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act when there is imminent danger to life or property during a state of calamity or when time is of the essence arising from natural or man-made calamities


WHEREAS, the BAC invited and engaged in negotiation with hotel establishments in the City with good track records and good standing with the City Government of Catbalogan to be used by the frontliner namely: VISMIN GV HOTEL INC., M GRAND ROYALE RESORT AND ASIA NOVO BOUTIQUE HOTEL INC. but only the last-mentioned submitted a quotation.

WHEREAS, upon careful and judicious evaluation by the BAC, ASIA NOVO BOUTIQUE HOTEL INC, was assessed to have tendered the only and final offer in the total amount of One Million Three Hundred Seventy Three Thousand (P1,373,000.00) vis-à-vis the Approved Budget for the Contract of One Million Three Hundred Seventy Three Thousand (P1,373,000.00), meeting the minimum technical requirements, conditions and specifications.


NOW, THEREFORE, WE, the members of the Bids and Awards Committee, do hereby RESOLVE, as it is hereby RESOLVED;


