**RESOLUTION DECLARING MHIRADGE ENTERPRISES AS THE BIDDER WITH THE LOWEST, CALCULATED AND RESPONSIVE BID FOR THE NEGOTIATED PROCUREMENT OF FORTY (40) SACKS COMMERCIAL RICE and RECOMMENDING AWARD BY THE HONORABLE CITY MAYOR**

WHEREAS, the BIDS AND AWARDS COMMITTEE (BAC) intended to procure **Commercial Rice** with an Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos (**P100,000.00**) for **City Health Office** activities.

WHEREAS, the BAC recommended to the honorable City Mayor **Small Value Procurement** as the mode of procurement for the above-stated items considering that said procurement falls under Small Value and whose ABC does not exceed the P400,000.00 threshold for fifth class city like Catbalogan pursuant to Rule XVI Section 53.9 of the Implementing Rules and Regulation of RA 9184 otherwise known as the Government Procurement Reform Act.


WHEREAS, the BAC invited PhilGEPS- registered service providers engaged in Groceries and with good track records and in good standing with the City Government namely: 1.) MHIRADGE ENTERPRISES 2) SANLESS STORE and 3) 4 EVER STORE, PIER 1 and all responded.

WHEREAS, said bidders submitted their respective quotations and upon careful and judicious evaluation by the BAC, **MHIRADGE ENTERPRISES** was assessed to have tendered the best and final offer of **NINETY NINE THOUSAND EIGHT HUNDRED PESOS (P99,800.00)** vis-à-vis the Approved Budget for the Contract of **ONE HUNDRED THOUSAND PESOS (P100,000.00)**, meeting the minimum technical requirements, conditions and specifications.


NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby **RESOLVE**, as it is hereby **RESOLVED**:




