Resolution No. 2020- 134- 6 (AWARD)

RESOLUTION DECLARING ALEGRO HOTEL & RESTAURANT AND TIA ANITA BREAD & BREAKFAST AS THE SERVICE PROVIDERS OF HOTEL ACCOMMODATIONS OF BID ITEMS 1 AND 2, RESPECTIVELY, FOR FRONTLINERS UNDER NEGOTIATED EMERGENCY CASE MODALITY TO COMBAT THE COVID-19 PANDEMIC AND RECOMMENDING AWARD BY THE HONORABLE MAYOR.

WHEREAS, the BIDS AND AWARDS COMMITTEE (BAC) intends to procure for Hotel Accommodation for Frontliners with an Approved Budget for the Contract (ABC) OF TWO MILLION THREE HUNDRED TWENTY TWO THOUSAND PESOS (P2,322,000.00) in response to the COVID-19 Pandemic in the City as follows:

ITEM 1: 1 Bldg. Five (5) Rooms with the necessary facilities for Frontliners and kitchen that will be utilized for food preparation of meals for Frontliners and Locally Stranded Individuals for Three (3) Months in the amount of P540,000.00,

ITEM 2: 12 Rooms with facilities for Frontliners for Three (3) Months or 90 Days- P1,782,000.00.

WHEREAS, the BAC recommended to the honorable City Mayor EMERGENCY CASES as the mode of procurement for the above-stated goods considering that said goods fall under Negotiated Procurement Emergency Cases pursuant to Section 53.2 Rule XVI of the Implementing Rules and Regulations of R.A. 9184 otherwise known as the Government Procurement Reform Act.

WHEREAS, there is imminent danger to life or property during a state of calamity or when time is of the essence arising from natural or man-made calamities.

WHEREAS, the BAC invited and engaged in negotiation with Hotel Establishments with good track records and in good standing with the City Government of Catbalogan, namely: ALEGRO HOTEL AND RESTAURANT, CASA CRISTINA HOTEL, ASIA NOVO BOUTIQUE, INC., TIA ANITAS BREAD AND BREAKFAST, CDDSSKE HOTEL CORP. and LCD HOTEL and all responded.

WHEREAS, said bidders submitted their respective quotations and upon careful and judicious evaluation by the BAC, **TIA ANITA BREAD & BREAKFAST and ALEGRO HOTEL & RESTAURANT** was assessed to have tendered the best and final offer as service providers of HOTEL ACCOMMODATION of **FIVE HUNDRED FORTY THOUSAND PESOS (P540,000.00)** and **ONE MILLION SEVEN HUNDRED EIGHTY-TWO THOUSAND PESOS (P1,782,000.00)** for bid ITEM 1 & 2, Respectively. Vis-à-vis the Approved Budget for the contract of **TWO MILLION THREE HUNDRED TWENTY-TWO THOUSAND PESOS (P2,322,000.00)**, thus meeting the minimum technical requirements, conditions and specifications.

NOW, THEREFORE, We, the members of the Bids and Awards Committee, do hereby RESOLVE, as it is hereby RESOLVED: ALEGRO HOTEL & RESTAURANT

- A) To declare **TIA ANITAS BREAD AND BREAKFAST and ALEGRO HOTEL & RESTAURANT**, as each bidder with the Lowest, Calculated and Responsive Bid for the Hotel Accommodations of Frontliners for Item No.1- 1 Bldg. Five (5) rooms with necessary facilities for Frontliners and Kitchen that will be utilized for Food Preparation of Meals for Frontliners and Locally Stranded Individuals for Three (3) Months in the amount of P540,000.00, and Item No.2- 12 rooms with facilities for Frontliners for Three (3) Months or 90 Days- P1,782,000.00, Respectively.
- B) To recommend the award by the Hon. City Mayor or his authorized representative of the above-stated project.


