INVITATION TO BID FOR GOODS 2021 -033 SUPPLY AND DELIVERY OF VARIOUS APPLIANCES AND EQUIPMENT

- The City Government of Catbalogan, through the DOLE Kabuhayan Projects Fund of Mayors Office (PESO) intends to apply the sum of Eight Hundred Thirty Eight Thousand Two Hundred Seventy Eight Thousand 65/100 Pesos (P838,278.65) Only, being the Approved Budget for the Contract (ABC) to payments under the contract for Goods 2021-033 Bids received in excess of the ABC shall be automatically rejected at bid opening.
 - The City Government of Catbalogan invites bids for the procurement of various appliances. Delivery of the Goods is required within Twenty five (25) Calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
 - Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
- Interested bidders may obtain further information from Bids and Awards Committee secretariat, City Procurement Office 4th Floor City Hall Catbalogan City and inspect the Bidding Documents at the address given below during 10:00 am to 5:00 pm, from the date of posting until Bid Opening.

5. A complete set of Bidding Documents may be acquired by interested Bidders on September 16 to October 6, 2021 –2:00pm from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (P1,000.00).

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. The City Government of Catbalogan will hold a Pre-Bid Conference on September 24, 2021 10:00 am at City Procurement Office, 4th Floor City Hall, Catbalogan City, which shall be open to prospective bidders.

8. Bids must be duly received by the BAC Secretariat at the address below on or before October 6, 2021 – 2:00 pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on October 6, 2021 – 2:00 pm at City Procurement Office 4th Floor City Hall, Catbalogan City. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The City Government of Catbalogan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
